Privacy Manager

Privacy Manager is the "automatic gatekeeper" that allows every user to be responsible for running their own reports and maintaining their own data. Now, access to a Microsoft Dynamics® SL (Solomon®) screen or report means users don't get to see all the data. Privacy Manager restricts each user to viewing and updating only the data matching their individual access permissions.

Use any of 50 Dynamics SL (Solomon) key fields to specify access permissions. An additional 16 custom permission fields allow custom applications and thirdparty applications to be privacy-enabled.


Specify a single permitted value, use wildcards to specify a range of values, or use advanced criteria to set up permissions such as 'everything but ...' or 'in the list ...'.

Limit access for each user based on subaccount, project id, ledger id, currency id, state, country, customer number, ship to location, customer class, sales person, territory, vendor, vendor class, buyer id, inventory id, inventory class, site id, product line, employee id and more.

Privacy Manager also allows you to restrict access based on accounting periods and document data. Prevent users from creating batches for past periods. Limit a user's access to current records.

Set up multiple restrictions on screens and reports. Privacy Manager automatically ignores the restrictions that do not apply to a particular user.

For example, a single customization can tailor the Project Maintenance screen so that project managers see only their own projects, managers are permitted to access all projects for their office, and headquarters staff are permitted access to all projects other than a list of internal management projects.



Privacy Manager works automatically once installed. Once Privacy Manager is installed for a screen or report, each user is only able to view update, update or create records which meet their personal privacy permissions. Users without a Privacy Manager Permission record are denied access to any data.

Privacy Manager is easy to implement and maintain.

- One User Permission record per user
- One Report Privacy Template per report format.
- One Privacy Customization per screen.

Virtually every Dynamics SL report and data entry screen becomes a self-service application with Privacy Manager.
